

NOTICE OF PROPOSAL

THE FLINTSHIRE COUNTY COUNCIL (VARIOUS ROADS WITHIN FLINTSHIRE) (30 mph Speed Limit) Order 202-

The Flintshire County Council hereby gives notice that it proposes to make an Order under Section 84 of the Road Traffic Regulation Act 1984, and of all enabling powers, the effect of which will be:-

- a) To impose a speed limit of 30mph on the roads as specified in the Schedules to this notice.

SCHEDULE 1 30MPH Speed Limit MOLD

A541 HENDRE, MOLD: From a point 490 metres east of its junction with Dolfechlas Road with the A541, for a distance of 514 metres in an easterly direction.

A541 DENBIGH ROAD, MOLD: from a point 17 metres north west of the junction of Factory Pool Lane with the A541 for a distance of 335 metres in a south easterly direction.

SCHEDULE 2 30MPH Speed Limit CONNAHS QUAY

B5129 KELSTERTON ROAD: from the junction with the A548 roundabout, for a distance of 410 metres in an easterly direction.

The Flintshire County Council (hereinafter referred to as “the Council”) in exercise of its powers under Section 82 (2) (a), 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the “Act of 1984”) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. In this Order except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
2. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of roads specified in the Schedules to this Order.
3. The road specified in the Schedule 1, 2, 3, 4, 5, 6, 7 & 9 to this Notice, shall cease to be a Restricted Road for the purposes of Section 81 of this Act
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. This Order shall come into operation on the xxth xx 202- and may be cited as The Flintshire County Council (VARIOUS ROADS WITHIN FLINTSHIRE) (30 mph Speed Limit) Order 20—

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The Welsh Government will introduce a national default 20mph speed limit on all restricted roads within Wales from 17th September 2023.

Restricted roads are usually located in residential and built-up areas and have a system of street lighting.

Welsh government have advised that reducing the speed limit from 30mph to 20mph on restricted roads could see many benefits. The advantages to a reduction in speed limit include;

- Improving safety around schools and other locations with high pedestrian traffic
- Improving safety for pedestrians and cyclists
- Discouraging 'rat running' through residential streets
- Improve accessibility by reducing motor vehicle dominance along the highway

'Place' criteria have been developed to determine where 20mph speed limits should be applied, providing a consistent approach across Wales.

Not all restricted roads that currently have a 30mph limit will be suitable to change to 20mph. In November 2022 Welsh Government introduced an 'exceptions criteria'. The purpose of this was to provide local councils with some flexibility to retain 30mph speed limits, where appropriate, on some restricted roads. These are termed as 'exceptions' to the default speed limit for restricted roads and Legal Orders are prepared to retain the current speed limit for these roads. All speed limits are assessed impartially and in accordance with specified national criteria.

To apply an 'exception' to a restricted road, local councils must have a clear and reasoned case for doing so, which demonstrates that strong evidence exists that retaining a higher speed limit would be safe.

Following an assessment of local roads, and working closely with County Councillors, a number of roads in Flintshire have been identified as possible exceptions which have been made available for public inspection on DataMap Wales.

The sections of road below are currently 30mph by restricted road status. The Authority considers that the existing 30 mph is an appropriate speed limit at these locations and as such do not meet the criteria or the nature of a road for a 20mph speed limit.

- St Davids Park - Ewloe
- A541 Hendre
- A541 Denbigh Road – Mold
- A5104 Warren Bank Interchange - Broughton
- A5026 Holway Rd - Holywell
- B5121 Greenfield Rd - Holywell
- B5129 Kelsterton Rd - Kelsterton
- B5129 Queensferry R'bout

- A549 Mold Rd – Mynydd Isa
- A549 Chester Rd / Dirty Mile - Little Mountain

The sections of road below are already subject to a 20mph speed limit which was implemented in 2022, as part of a first phase of implementation of a change in default speed limit to 20mph within Buckley and the surrounding areas. The Authority does not consider that the existing 20mph speed limit is an appropriate speed limit at these locations and as such do not meet the criteria or the nature of a road for a 20mph speed limit.

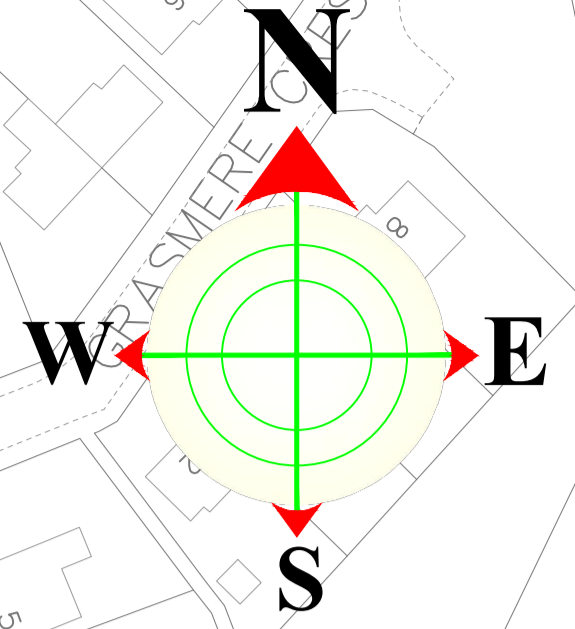
