Notice of Proposal

A5026 HOLWAY ROAD AND A5026 WHITFORD STREET, HOLYWELL PROPOSED PROHIBITION OF WAITING AT ANY TIME AND PROPOSED REVOCATION OF WAITING AT ANY TIME

Flintshire County Council propose to make an Order in exercise of its powers under the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, Part IV of Schedule 9 and all other enabling powers, the effect of which will be to amend The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013, so as to:-

- 1. Introduce 'No Waiting at Any Time' restrictions: -
- a. On the southwest side of the A5026 Holway Road, Holywell, near to the A5026 Whitford Street junction.
- 2. Revoke the existing 'No Waiting at Any Time' restrictions: -
- a. At various locations on the southwest side of A5026 Whitford Street, Holywell.

In all other respects the present provisions of the 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013' will remain in force.

SECTION 1 – PRELIMINARY

Citation and commencement

- This Order shall come into operation on the XXth XXX 202- and may be cited as The Flintshire County Council, A5026 Holway Road and A5026 Whitford Street, Holywell (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) (Amendment No. 67) Order 202-
- With effect from the date set out in Article 1 above, Map Schedules Y46 Sheet Revision No: 3, replaces Map Schedules Y46 Sheet Revision No: 2 and Map Schedules Y45 Sheet Revision No: 2, replaces Map Schedules Y46 Sheet Revision No: 1 respectively and all other map schedules together with the before mentioned Map Schedules and plans referred to in the Schedules to this Order are incorporated into The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013.
- 3. The interpretation Act 1978 shall apply for the interpretation on this Order as it applies for the interpretation of an Act of Parliament
- 4. In this Order, except where otherwise stated, any reference to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number and any reference to a plan is reference to a plan incorporated into this order.

PROPOSED PROHIBITION OF WAITING AT ANY TIME AND REVOCATION OF WAITING AT ANY TIME

Statement of Reasons for Proposing to Make the Order

A successful bid was made to the Welsh Government and as such Flintshire County Council have been successful in obtaining funding to implement substantial safety measures in the surrounding area of Ysgol Gwenffrwd and St Winefrides School.

As part of this, Flintshire County Council propose to introduce No Waiting at Any Time restrictions (double yellow lines) and the removal of sections of No Waiting at Any Time restrictions (double yellow lines), in the roads as listed above.

The Introduction of proposed No Waiting At Any Time restrictions, will improve safety for pedestrians and all road users through the removal of parked vehicles at key locations. It will also assist in the free flow of traffic and maintain visibility in the vicinity of the A5026 Holway Road with the A5026 Whitford Street junction.

The removal of No Waiting at Any Time restrictions on the A5026 Whitford Street, will legalise the existing illegal parking arrangements, whereby vehicles are parking behind the existing double yellow lines, which is an offence.

In the interests of road safety, the proposals are necessary to avoid danger to people or other traffic using the road or preventing danger arising.

The proposals are detailed in the Public Notice and in the proposed Order.




