SECTION 1 - PRELIMINARY

Citation and commencement

This Order shall come into operation on the 10th January 2025 and may be cited as (THE FLINTSHIRE COUNTY COUNCIL, CADOLE ROAD CADOLE. (VARIOUS ROADS) (20MPH, 30MPH, 40MPH, 50MPH AND NATIONAL SPEED LIMITS. RESTRICTED AND DERESTRICTED ROADS) (AMENDMENT NO. 04) ORDER 2024.

General Provisions

- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. In this Order, except where otherwise stated, any reference to a numbered Article or to the Schedule is a reference to the Article bearing that number and to the Schedule in this Order.
- 4. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the roads specified in the Schedule to this Order.
- 5. With effect from the date set out in Article 1 above, Map Schedule H10 and H11 Sheet Revision No: 3 which is incorporated in this Order, replaces Map Schedule H10 and H11, Sheet Revision 2, in The Flintshire County Council (Various Roads) (20mph, 30mph, 40mph, 50mph and National Speed Limits. Restricted and Derestricted Roads) Order 2023, in respect of the roads specified in the Schedule to this Order.

STATEMENT OF REASONS FOR PROPOSING TO MAKE ORDER

It is proposed to introduce a 40mph speed limit on Cadole Road, from its junction with the A494 to a point 323 metres in a Northerly direction.

A 40mph speed limit should be considered where there are many junctions or accesses, substantial development, a strong environmental with a predominantly local, access or recreational function, or where there are a considerable numbers of vulnerable road users.

When assessed in accordance with current criteria, it is felt that a 40mph is an appropriate speed limit at this location, due to the overall property density and will also serve as a extension of the existing 40mph speed limit on the A494 but also as a transitional speed limit on the approach to the A494 Trunk road.

The Authority continues its responsibility to consider the provision of convenient and safe movement of motor vehicles and other traffic, and the proposed measures are aimed at ensuring that danger is minimised to all road users aswell as improving the amenities of the locality.

The proposals are detailed in the Public Notice and are contained in the proposed Draft Order.
