A5026 HOLWAY ROAD, HOLYWELL: from a point 680 metres North West of its junction with Saith Aelwyd Park, to a point 52 metres north west of its junction with Carmel Road.

A5026 HOLWAY ROAD, HOLYWELL: from a point 640 metres North West of its junction with Saith Aelwyd Park, to a point 52 metres north west of its junction with Carmel Road.

1. In this Order except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
2. The Flintshire County Council (VARIOUS ROADS WITHIN FLINTSHIRE) (30 mph Speed Limit) Order 2023 shall have effect as though in the fifth Schedule to that Order, the words :-

A5026 HOLWAY ROAD, HOLYWELL: from a point 680 metres North West of its junction with Saith Aelwyd Park, to a point 52 metres north west of its junction with Carmel Road.


