

**THE FLINTSHIRE COUNTY COUNCIL  
HIGH STREET AND ROADS ADJACENT, HOLYWELL  
(ONE WAY TRAFFIC AND PROHIBITION OF DRIVING) ORDER 20xx.**

The Flintshire County Council hereby gives notice that it proposes to make an Order in exercise of its powers under the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) under Sections 1 (1) (d) (f) and 2 (1) (2) and all other enabling powers, the effect of which will be to:-

1. Prohibit any vehicle from proceeding in the lengths of road specified in Column 1 of Schedule 1 to this Notice in a direction other than that specified in relation to those lengths of road in Column 2.
2. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Markets Officer, cause or permit any vehicle to proceed in the length of Tower Gardens from its junction with High Street, for a distance of 60 metres in a North Easterly direction.
3. No person shall, except upon the direction or with the permission of a Police Constable in uniform cause or permit any vehicle to enter or leave High Street at its junction with Station Road adjacent to numbers 17 and 21.
4. This proposed Order if made, will revoke THE FLINTSHIRE COUNTY COUNCIL HIGH STREET AND ROADS ADJACENT, HOLYWELL (ONE WAY TRAFFIC AND PROHIBITION OF DRIVING) ORDER 2019 in its entirety.

Flintshire County Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1 (1) (d) (f) and 2 (1) (2) of the Road Traffic Regulation Act 1984 (“the Act of 1984”) as amended and of all other enabling powers, hereby makes the following Order :-

1. In this Order except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
2. No person shall, except upon the direction or with the permission of a Police Constable in uniform cause or permit any vehicle to proceed in the length of roads specified in column 1 of Schedule 1 to this Order in a direction other than that specified in relation to those lengths of roads in Column 2 to the Schedule.
3. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Markets Officer, cause or permit any vehicle to proceed in the length of Tower Gardens, from its junction with High Street, for a distance of 60 metres in a North Easterly direction.
4. No person shall, except upon the direction or with the permission of a Police Constable in uniform cause or permit any vehicle to enter or leave High Street at its junction with Station Road adjacent to numbers 17 and 21.
5. Nothing in Article 2 of this Notice, shall apply as to prevent any person from causing any vehicle to proceed in the length of roads specified, if the vehicle is being used for fire brigade, ambulance or police purposes.
6. Flintshire County Council (High Street and Roads Adjacent, Holywell) (One Way Traffic and Prohibition of Driving) Order 2019 is hereby revoked.
7. The prohibitions and restrictions imposed by this Order shall be in addition to and not in

derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

8. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

9. This Order shall come into operation on the xx xxxxxxxx 20xx and may be cited as The Flintshire County Council (High Street and Roads Adjacent, Holywell) (One Way Traffic and Prohibition of Driving) Order 20xx.


**STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER**

A Holywell Market Review consultation has taken place, to share a proposal which would relocate the Holywell Market to Tower Gardens and opening the High Street to vehicular traffic each Thursday, in an attempt to help boost local trade.

The views from Holywell residents, businesses and Market traders were taken into consideration and the outcome of the results confirmed the intention to relocate Holywell Market from the High Street to Tower Gardens each Thursday, was looked upon positively.

Therefore, the Traffic Regulation Order made in 2019 will be revoked and will reflect the changes above, which will allow vehicular traffic to now enter the High Street on such Thursdays as a street market is being held in Tower Gardens and will allow vehicular traffic to enter Tower Gardens, with the permission of a Police Constable in uniform or a Markets Officer.
