**SECTION 23 OF THE ROAD TRAFFIC REGULATION ACT 1984**

**PROPOSED PEDESTRIAN CROSSING ON THE A549 MOLD ROAD, BUCKLEY**

**NOTICE** is hereby given that the Flintshire County Council, in exercise of its powers under Section 23 of the Road Traffic Regulation Act 1984 and all other enabling powers proposes:-

- a) The installation of a Puffin Pedestrian Crossing at the location as described in the Schedule to this Notice.

**Reason for Proposal:** Flintshire County Council has identified the A549 Mold Road, Buckley as a location suitable for a Puffin crossing facility. Flintshire County Council have been successful in obtaining funding to implement a permanent crossing facility at the location in which the School Crossing Patrol currently operates, which will aid sustainable journeys to school. The facility will benefit not only children travelling to and from school during regular start and finish times but also those attending morning or after school clubs when there is no patrol on duty or during absences. Additionally, it will serve the wider community by providing a safe crossing point outside of school hours.

The usual prohibition of vehicles stopping, waiting, loading and unloading on the carriageway within the areas marked by Zig Zag lines on either side of the crossing will apply.



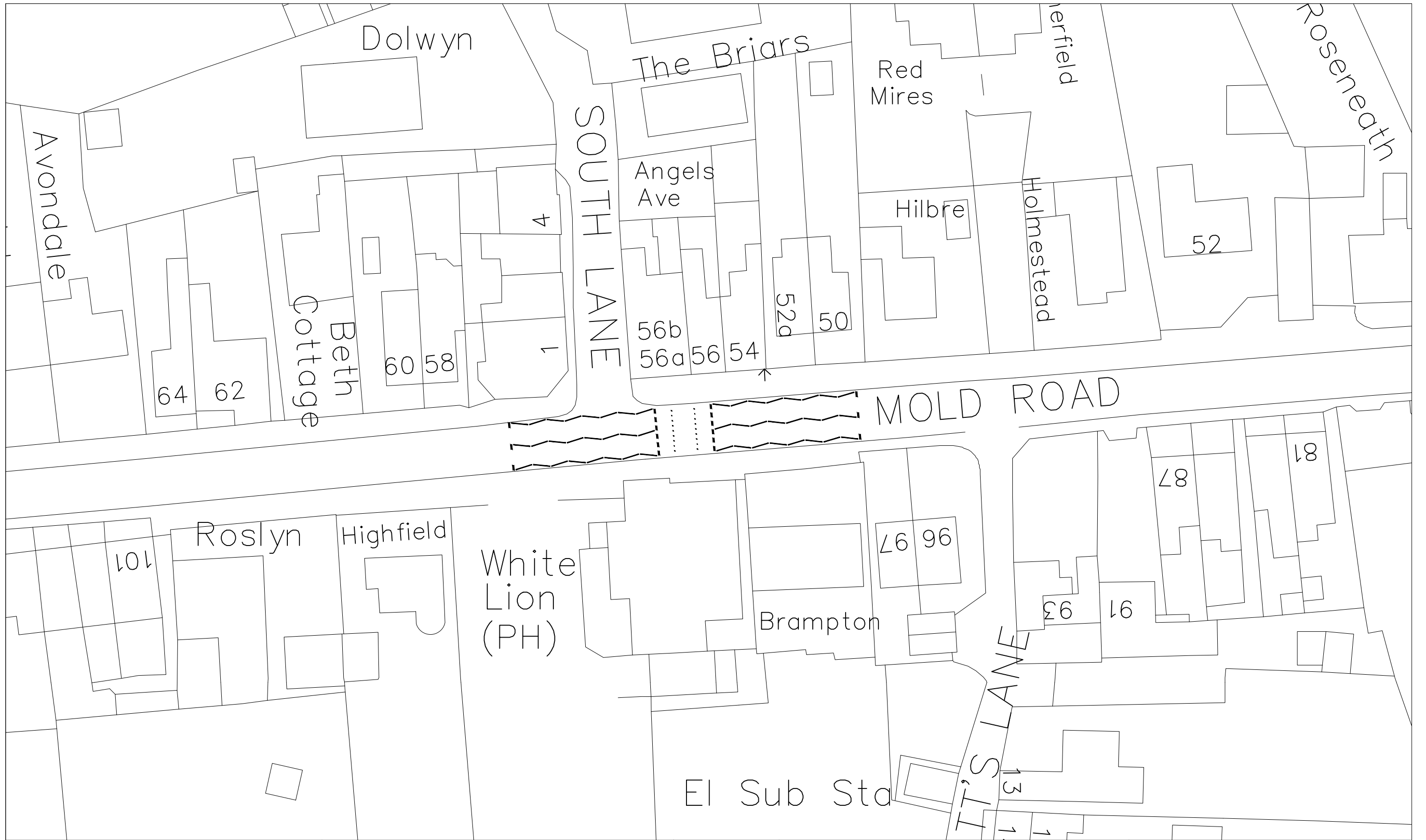
**New Puffin Pedestrian Crossing to be installed.**
