

## **Notice of Making**

### **A5026 HOLWAY ROAD, A5026 FRON PARK ROAD AND A5026 WHITFORD STREET AND SURROUNDING ROADS, HOLYWELL**

### **PROHIBITION OF WAITING AT ANY TIME AND BUS STOP CLEARWAY**


Notice is hereby given that on the 19<sup>th</sup> February 2025, Flintshire County Council made an Order in exercise of its powers under the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, Part IV of Schedule 9 and all other enabling powers, the effect of which will be to amend The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013, so as to:

1. Introduce 'No Waiting at Any Time' restrictions:-
  - a. At the junction of the A5026 Holway Road and Gwel Afon, Holywell.
  - b. At the junction of the A5026 Holway Road and Wedgewood Heights, Holywell.
  - c. At the junction of the A5026 Holway Road and the A5026 Whitford Street, Holywell.
  - d. At various locations on both sides of the A5026 Holway Road, Holywell.
  - e. At various locations on both sides of the A5026 Fron Park Road, Holywell
  - f. At the junction of the A5026 Whitford Street and Ael-y-Ffynnon, Holywell.
2. Revoke the existing 'School Terms - Monday – Friday 8.15am - 9.15am and 2.45pm-4.00pm School Buses Only' parking restrictions and introduce a 'Bus Stop Clearway Monday – Friday 7am – 7pm' in the Lay-by outside the pedestrian access to St Winefrides Catholic Primary School, on the A5026 Whitford Street, Holywell.

In all other respects the present provisions of the 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013' will remain in force.

Should you wish to view a copy of this Notice, the Order which will come into operation on the 27<sup>th</sup> February 2025, plans showing the roads affected and a statement of the Council's reasons for the making of the Order, they may be inspected during normal opening hours at Flintshire Connects, 24 High Street, Holywell CH8 7LH. Flintshire County Council in exercise of its powers under sections 1 (1), 2 (1)(2), 4 (2)(3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") as amended, the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

**SECTION 1 – PRELIMINARY**

**Citation and commencement**

1. This Order shall come into operation on the 27<sup>th</sup> February 2025 and may be cited as The Flintshire County Council, A5026 Holway Road, A5026 Fron Park Road and A5026 Whitford Street and surrounding roads, Holywell (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) (Amendment No. 65) Order 2025
2. With effect from the date set out in Article 1 above, Map Schedules Y46 Sheet Revision No: 2, replaces Map Schedules Y46 Sheet Revision No: 1 respectively and all other map schedules together with the before mentioned Map Schedules and plans referred to in the Schedules to this Order are incorporated into The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013.
3. The interpretation Act 1978 shall apply for the interpretation on this Order as it applies for the interpretation of an Act of Parliament
4. In this Order, except where otherwise stated, any reference to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number and any reference to a plan is reference to a plan incorporated into this order.

**PROPOSED PROHIBITION OF WAITING AT ANY TIME AND REVOCATION OF WAITING AT ANY TIME**

**Statement of Reasons for Proposing to Make the Order**

A successful bid was made to the Welsh Government and as such Flintshire County Council have been successful in obtaining funding to implement substantial safety measures in the surrounding area of Ysgol Gwenffrwd and St Winefrides School.


Flintshire County Council propose to introduce No Waiting at Any Time restrictions (double yellow lines) and a Bus Stop Clearway 7am-7pm Monday - Friday, in the roads as listed above.

The Introduction of proposed No Waiting At Any Time restrictions, will improve safety for pedestrians and all road users through the removal of parked vehicles at key locations, whilst also improving traffic flow around Ysgol Gwenffrwd and St Winefrides Primary School. It will also ensure access is maintained for residents, prevent obstruction, maintain visibility at the junctions and ensure that the junctions are not obstructed by parked vehicles.

The Introduction of a proposed Bus Stop Clearway, will address obstructive parking at this location, through the removal of indiscriminately parked vehicles within the school bus stop lay-by, thus improving safety for pedestrians and all road users.

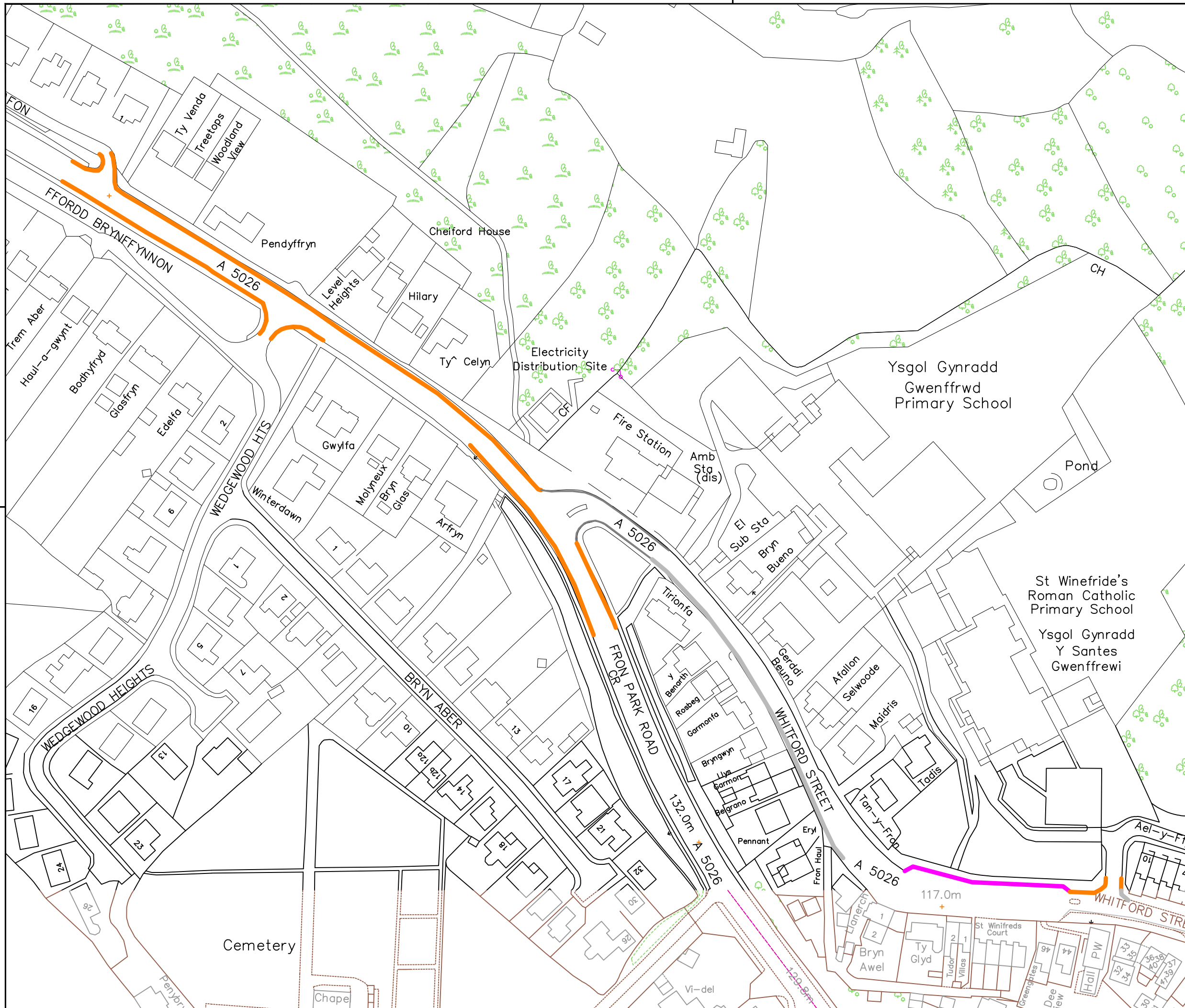
In the interests of road safety, the proposals are necessary to avoid danger to people or other traffic using the road or preventing danger arising.

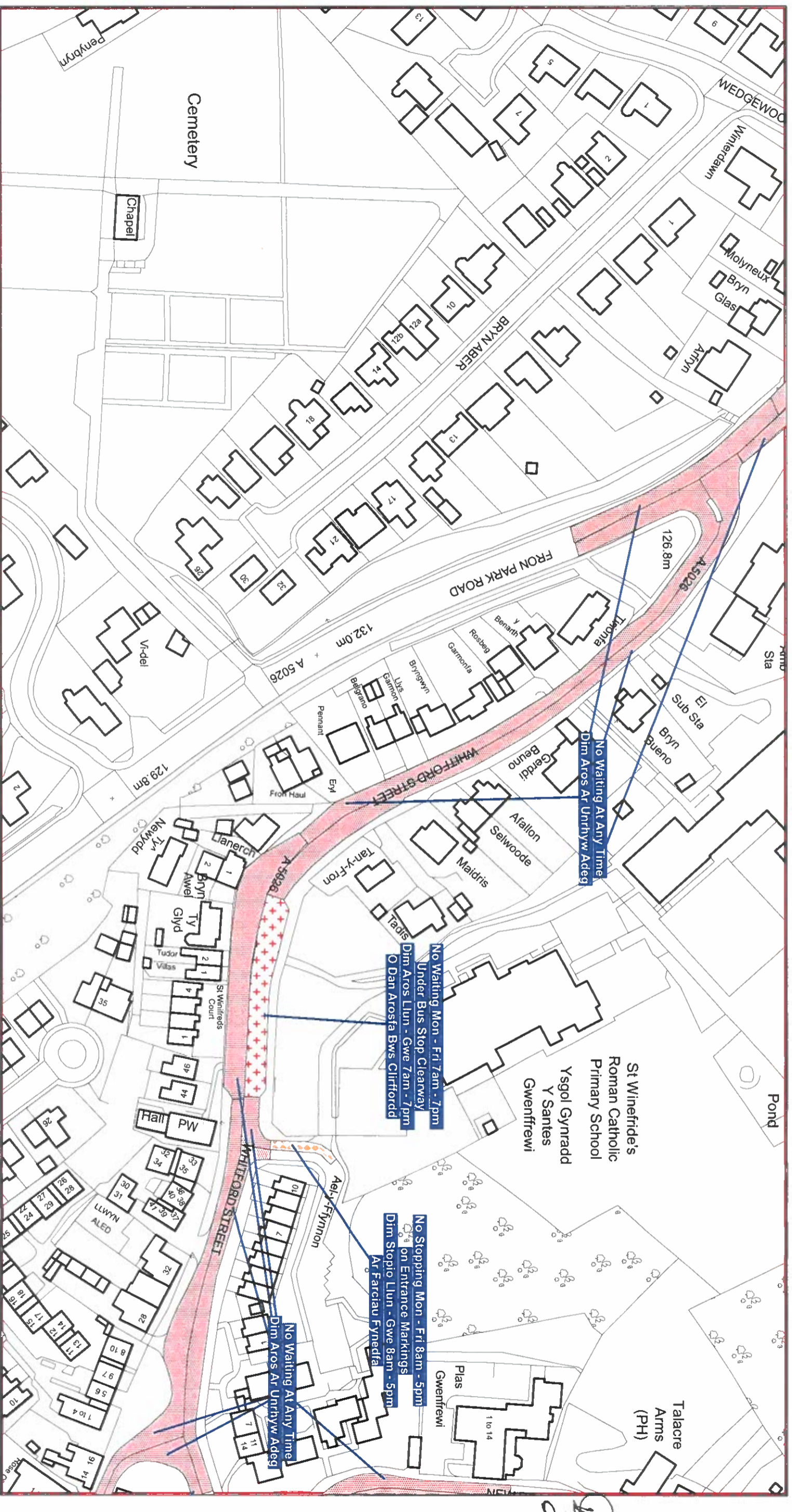

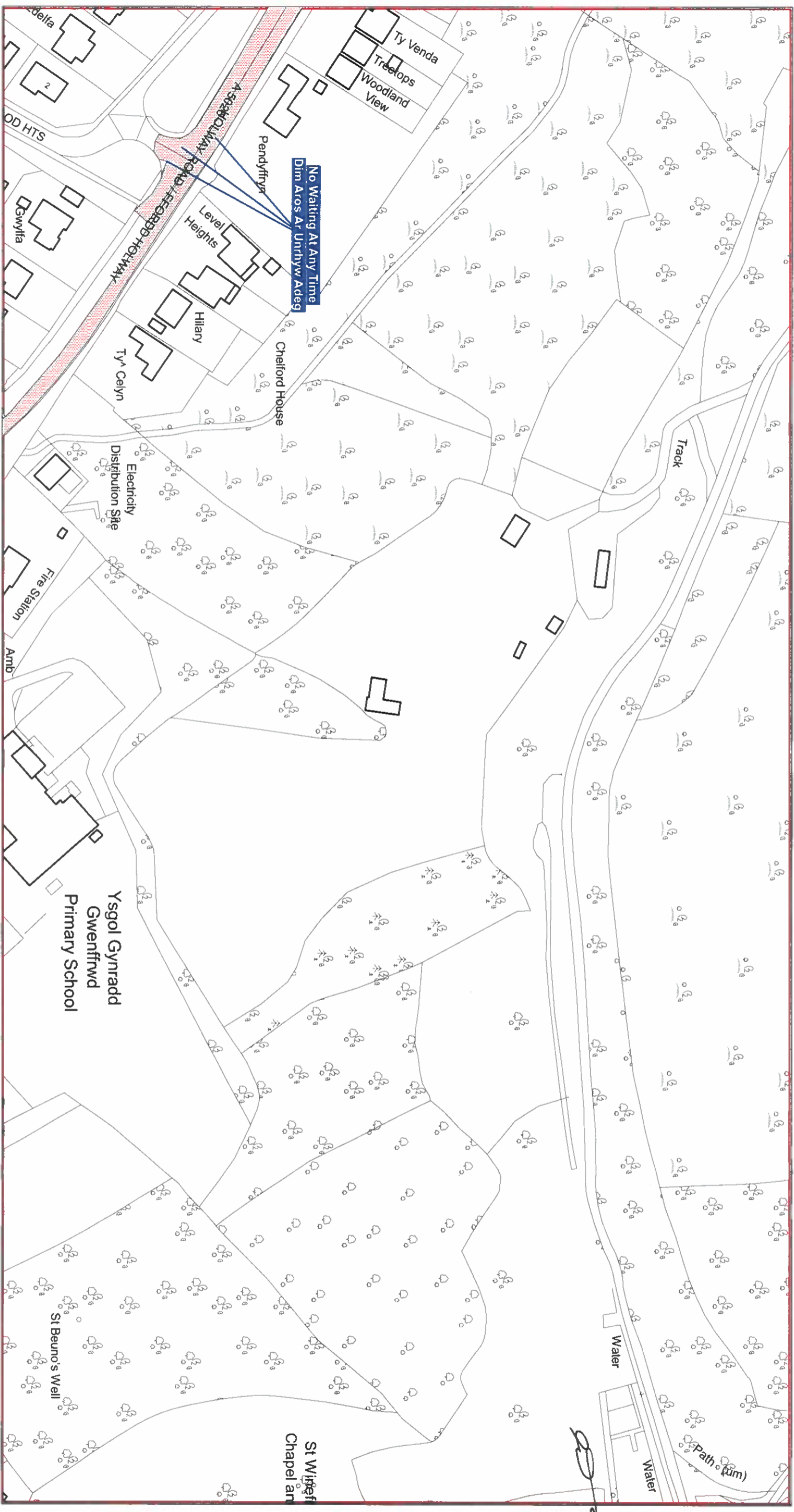
