THE FLINTSHIRE COUNTY COUNCIL

(VARIOUS ROADS) (20MPH, 30MPH, 40MPH, 50MPH AND NATIONAL SPEED LIMITS. RESTRICTED AND DERESTRICTED ROADS)

VARIOUS UNNAMED ROADS, UNNAMED LANES AND TREM Y FOEL RHES Y CAE, HOLYWELL. (20MPH SPEED LIMIT) (AMENDMENT NO. 12) ORDER 2025

Notice is hereby given that on the 1st April 2025, Flintshire County Council made an Order in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 and Part IV of Schedule 9 to the Act and of all other enabling powers, the effect of which will be to amend The Flintshire County Council (Various Roads) (20mph, 30mph, 40mph, 50mph and National Speed Limits. Restricted and Derestricted Roads) Order 2023, so as to impose:

a) A 20mph speed limit by Order on:-

Trem Y Foel: for its entire length.

Unnamed Road 1: from a point 94 metres south east of its south westerly junction with Ffordd Y Graig (near Black Lion Farm), to a point 249 metres north west of its junction with the unnamed road 2.

Unnamed road 2: from its junction with the unnamed road 1 to a point 149 meters north of its junction with unnamed road 3.

Unnamed road 3: from its junction with the unnamed road 2, for a distance of 125 metres in a south easterly direction.

Unnamed Lane 1: from its junction with the unnamed Road 1 to its junction with the unnamed road 3.

Unnamed Lane 2: from its junction with the unnamed road 2, for its entire length.

Unnamed Lane 3: from its junction with the unnamed road 2, for its entire length.


Unnamed Lane 4: from its junction with unnamed road 2 for its entire length.

The Order, will revoke The Flintshire County Council (Various Unnamed Roads, Unnamed Lanes and Trem y Foel, Rhes y Cae, Holywell) (30mph Speed Limit) Order 2019 in its entirety and be consolidated into The Flintshire County Council (Various Roads) (20mph, 30mph, 40mph, 50mph and National Speed Limits. Restricted and Derestricted Roads) Order 2023.

In all other respects the present provisions of The Flintshire County Council (Various Roads) (20mph, 30mph, 40mph, 50mph and National Speed Limits. Restricted and Derestricted Roads) Order 2023 will remain in force.

The Flintshire County Council (hereinafter referred to as “the Council”) in exercise of its powers under Section 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as the “Act of 1984”) and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

SECTION 1 – PRELIMINARY

Citation and commencement

1. This Order shall come into operation on the 21st April 2025 and may be cited as (THE FLINTSHIRE COUNTY COUNCIL, VARIOUS UNNAMED ROADS, UNNAMED LANES AND TREM Y FOEL RHES Y CAE, HOLYWELL. (VARIOUS ROADS) (20MPH, 30MPH, 40MPH, 50MPH AND NATIONAL SPEED LIMITS. RESTRICTED AND DERESTRICTED ROADS) (AMENDMENT NO. 12) ORDER 2025

General Provisions

2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. In this Order, except where otherwise stated, any reference to a numbered Article or to the Schedule is a reference to the Article bearing that number and to the Schedule in this Order.
4. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the roads specified in the Schedule to this Order.
5. This Order revokes The Flintshire County Council (Various Unnamed Roads, Unnamed Lanes and Trem y Foel, Rhes y Cae, Holywell) (30mph Speed Limit) Order 2019 in its entirety.

6. With effect from the date set out in Article 1 above, Map Schedule G18 and G19 Sheet Revision No: 2 which is incorporated in this Order, replaces Map Schedule G18 and G19, Sheet Revision 1, in The Flintshire County Council (Various Roads) (20mph, 30mph, 40mph, 50mph and National Speed Limits. Restricted and Derestricted Roads) Order 2023, in respect of the roads specified in the Schedule to this Order.

1. In this Order except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
2. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of roads specified in the Schedule to this Order and on Map Schedules G18 and G19.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, all Flintshire County Council traffic regulation orders pertaining to a speed limit on any length of a road subject to this Order are hereby revoked to the extent that they are inconsistent with this Order.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. This Order shall come into operation on the 06th May 2019 and may be cited as The Flintshire County Council (Various Unnamed Roads, Unnamed Lanes and Trem y Foel, Rhes y Cae, Holywell) (30mph Speed Limit) Order 2019

Unnamed road 1 shall mean the Unnamed Road from Lixwm to Mole y Crio at Rhes y Cae:

Unnamed Road 2 shall mean the unnamed road from from Rhes y Cae to Pentre Halkyn

Unnamed Road 3 shall mean the unnamed road from from Rhes y Cae to Halkyn

Unnamed Lane 1 shall mean the lane between unnamed road 1 and unnamed road 3

Unnamed Lane 2 shall mean the lane with both junctions on the unnamed road 2.

Unnamed Lane 3 shall mean the lane from unnamed road 2 to unnamed lane 2

Unnamed Lane 4 shall mean the lane between unnamed road 2 and unnamed lane 1



Rhes-y-cae is a small parish and village located between Pentre Halkyn and Rhosesmor.

In September 2023 the default Speed Limit along restricted roads within Wales was reduced to 20 mph. The current 30mph Speed Limit by Order is not appropriate for this area due to the introduction of the 20mph speed limit throughout Wales for built up areas and villages.


This will introduce a 20 mph speed limit on the lengths of road specified within the Order, which due to limited street lighting did not meet the criteria for a restricted road and therefore the speed limit remained as 30mph. In light of this, it is recommended to introduce a 20mph speed limit, which is appropriate for a defined village and due to the lack of footway provision in places.

Local representation has suggested that a reduction in the speed of traffic through the area would be beneficial in terms of promoting safer roads and is supported by the local community.



The introduction of a 20mph speed limit on these lengths of road has the following benefits for all road users:

- Improving safety for pedestrians and cyclists
- Encourage more people to walk and cycle
- Help to improve health and well-being
- Improve accessibility by reducing motor vehicle dominance along the highway
- Safeguard the environment for future generations

The County Council continues its responsibility to consider the provision of convenient and safe movement of motor vehicles and other traffic, and the proposed measures are aimed at ensuring that danger is minimised to vulnerable road users as well as improving the amenities of the locality.
