SECTION 1 – PRELIMINARY

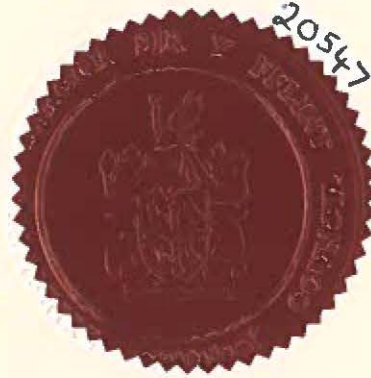
Citation and commencement

1. This Order shall come into operation on the 30th March 2023 and may be cited as The Flintshire County Council, FFORDD LLEWELYN, FLINT (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) (Amendment No. 53) Order 2023
2. With effect from the date set out in Article 1 above, Map Schedule AL61 Sheet Revision No: 2 replaces Map Schedule AL61 Sheet Revision 1 and Map Schedule AM61, Sheet Revision No: 3, replaces Map Schedules AM61 Sheet Revision No: 2 and all other map schedules together with the before mentioned map schedules and plans referred to in the Schedules to this Order are incorporated into The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013.
3. The interpretation Act 1978 shall apply for the interpretation on this Order as it applies for the interpretation of an Act of Parliament
