Notice is hereby given that on the 11th March 2025, Flintshire County Council made an Order in exercise of its powers under the Road Traffic Regulation Act 1984, the Traffic Management Act 2004, Part IV of Schedule 9 and all other enabling powers, the effect of which will be to amend The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013, so as to introduce:-

- 1. 'No Waiting At Any Time' restrictions-:
 - a. At various locations on both sides of Golftyn Lane, Connah's Quay
 - b. At various locations on both sides of Golftyn Drive, Connah's Quay
 - c. At various locations on both sides of Kelsterton Court, Connah's Quay
 - d. At the junction of Golftyn Drive with Hafod Close, Connah's Quay
 - e. At the junction of Golftyn Drive with Holly Close, Connah's Quay
 - f. At the junction of Golftyn Drive with College View, Connah's Quay
 - g. At the junction of Golftyn Drive with Golftyn Lane, Connah's Quay
 - h. At the junction of Vermeer Close with Hals Close, Connah's Quay
 - i. At the junction of Golftyn Lane with Golftyn Lane, Connah's Quay

In all other respects the present provisions of the 'The Flintshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2013' will remain in force.

Should you wish to view a copy of this Notice, the Order which will come into operation on the 28th March 2025, plans showing the length of roads to which the Order relates and a statement of the Council's reasons for the making of the Order, they may be inspected during normal opening hours at Flintshire Connects, Wepre Drive, Connah's Quay CH5 4HA. If you wish to question the validity of the Order or any of its provisions on the grounds that any requirements of the Act or any instruments made under it has not been complied with, you may, within 6 weeks from the date on which the Order is made, apply for the purpose to the High Court.
