The Flintshire County Council (hereinafter referred to as "the Council") in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. In this Order except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order
1. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the length of roads specified in the Schedules to this Order and on Map Schedule M16 and M17.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. This Order shall come into operation on the 30<sup>th</sup> April 2021 and may be cited as The Flintshire County Council (KING GEORGE STREET, MOSTYN STREET, WOODLAND STREET, WOODLAND CRESECENT, PLYMOUTH STREET, UNNAMED ROAD, VICTORIA ROAD, ROWDEN STREET, BEACONSFIELD ROAD, KINGSWAY, ROWDEN CRESCENT, VICTORIA CRESCENT , GLADSTONE STREET, GARDEN WAY, QUEENSWAY, TALIESIN AVENUE, MILL VIEW ROAD, LLEWELYN STREET, SHOTTON) (20 mph Speed Limit and 20 mph Speed Limit Zone) Order 2021
